### **III. APPROVAL OF MINUTES**

#### ***A. Approval of the minutes of the October 7, 2024 Regular meeting.***

On motion by Councilman Wall, seconded by Councilwoman Haroian, it was voted to approve the minutes of the October 7, 2024 regular meeting and they stand approved as recorded. Motion passed unanimously.

**Chair** stated that there are many many businesses that are trying to renew their license this evening and the Clerk's Office has done a remarkable job putting this agenda together trying to follow up and get all the missing pieces from a lot of the businesses and he spent some time today speaking with the Clerks and with Attorney Verdecchia and to be most business friendly, for this block of licenses in Roman Numeral V, they all agree that there should be a motion to approve all the licenses in this block subject to all the required documents and payments and he asked Solicitor to explain what the process will be BCI clearances.

**Solicitor** stated that in the past what we have done with outstanding items is we have granted but not issued and will continue to do that. As far as BCI check, the Clerk sent him a packet last week regarding the applicants who are on the agenda this evening. He has reviewed those BCI reports and State Law under Title 3 states that if a person has a conviction, that would authorize a denial of the license, however, Rhode Island also passed other legislation in 2020 and that really tightened up the conditions on which a City or Town can deny someone a license and they made it very clear that it takes more than just prior criminal history. Whatever offense is contained in a BCI report has to directly relate to the occupation that they are seeking or license that they are seeking and there are various factors that are weighed. He is satisfied and it is his judgment that none of these BCI reports that he has reviewed would qualify as disqualifying circumstances for any of the license applicants tonight. Some of the BCI checks are not in yet and the question was what happens when one comes in next week or two days from now and if the license was denied tonight, they would have to wait another month to obtain their license. What he suggests is that we adopt a policy whereby as the Clerks receive BCI checks from the applicant, the Clerk's Office forward the BCI checks to him and unless he sees something that he thinks is serious enough to warrant a disqualification or a denial, the license will be issued. As the Chair stated, we certainly want to be business friendly. We do not want people to wait unnecessarily to obtain their license. He is keeping a close watch on that. If the Committee is willing to grant that discretion to the Solicitor's Office and to himself, that would be policy we would have going forward.

**Stacy Thompson, Esq.**, 1 Turks Head Place, Suite 1200, Providence, appeared to speak on behalf of 401 Night Life, LLC, d/b/a Pregame Lounge.

**Solicitor** stated that the Committee may recall that approximately 1-1½ years ago there was a hearing and the Committee revoked the Entertainment License for the Pregame Lounge and that revocation was ultimately upheld by RI Supreme Court. There was an appeal taken from that. Approximately six months ago a Show Cause Hearing was held and at that time he asked the Committee, on behalf of the Administration, for revocation of the Victualling License as well as the Liquor License. At that time, one of the two proprietors was charged with a very serious drug offense and was not present for that hearing because he was locked up at the ACI. The other principal of the LLC was present, but she did not have time to hire an attorney. She did not have time to put on a case. We proceeded on an emergency type basis and he asked for the votes and the Committee voted to revoke both the Victualling License and the Liquor License at that time. Subsequent to that date, he has had discussions with Attorney Hemond and he entered an appearance on behalf of the Pregame Lounge. He asked for a full hearing. That would enable him to put a case on and evidence on behalf of his client and he thought that was a reasonable request because what we did the first time was on an emergency basis. A few weeks ago, he circulated a memorandum which was filed by Attorney Hemond on behalf of his client. So the record now is complete on the sense that the City has presented its side, the LLC and its representatives have presented their side so now we have had a complete hearing sort of speak. Now that that has been done and the evidence has all been submitted by both sides, he is asking for another vote this evening. The City is asking for two votes. We have not changed our position. We still maintain that the Victualling License should be revoked and the Liquor License should be revoked based on all of the evidence which was submitted at the prior hearing. The City is going to incorporate by reference all of the evidence that was submitted in order to keep the record clean. All that is needed this evening from the Committee is another vote on the revocation of the Victualling License and a separate vote on the revocation of the Liquor License. At that point in time, it will be out of our hands and the appeal process will then take place and DBR, Superior Court and the Supreme Court will deal with it from that point on. He stated that Attorney Thompson can certainly speak if she would like, but we are not going to hold another hearing and submit more evidence.

**Attorney Thompson** appeared to speak and stated that it was her understanding that the Liquor License issue had been postponed to December 9<sup>th</sup>. Solicitor stated that DBR is going to hold a hearing on Attorney Hemond's emergency motion on the Liquor License only. He indicated to the Hearing Officer that the Committee would be meeting this evening and would be taking another vote so that hearing will proceed on the 9<sup>th</sup>, but it does not affect anything with what we are doing this evening.
