**Chair** stated that he had discussions with Solicitor Verdecchia today and sees no problem with approving this license application subject to the receipt of the documents that are still needed from applicant.

**Solicitor** suggested that motion be made approving the license subject to applicant obtaining CO and State Health approval.

Attorney Murray presented an updated menu and stated that they are waiting for Certificate of Good Standing. On motion by Councilman Wall, seconded by Councilwoman Haroian, it was voted to recommend approval of this license application subject to City Clerk receiving Certificate of Good Standing and Health approval. Motion passed unanimously.

**Chair** indicated that Fire inspection was received with notation that a reinspection is to be done within next thirty days.

On motion by Councilman Wall, seconded by Councilwoman Haroian, it was voted to approve this license application subject to receipt of approval of Fire Department reinspection. Motion passed unanimously.

**Chair** stated that this item is listed on the agenda in error and no action is needed.

## 2. 404 Nightlife, LLC d/b/a Pre-Game Lounge located at 349 Dyer Ave.

**Solicitor** asked if anyone is present from Pregame Lounge. Jacqueline Blair appeared to represent Pregame Lounge. Solicitor asked what her relationship is or position is with this business. Ms. Blair stated that she is half owner. Solicitor stated that he looked at the Secretary of State website as of June 12th and Corporate Charter was revoked. He asked if that has been rectified. Ms. Blair stated, yes. Solicitor asked Ms. Blair if she had any documents showing that she is an owner because looking through the submissions on the website, there is no information there other than her being registered agent. He does not see any ownership interest. He does not see an operating agreement, any managers, anything like that. He asked Ms. Blair if she has any of that documentation this evening. Ms. Blair stated that Attorney Nick Hemond was supposed to represent her and David Cooper was assisting him, but Mr. Cooper tested positive for COVID and Attorney Hemond is on vacation. Due to that, she asked if she can get another hearing date when they are available. If not, she has her personal taxes and business taxes where it shows that she is half owner. Solicitor stated that unless the Committee feels differently. He would like to proceed this evening and he is going to put a case on and make his arguements to the Committee and Ms. Blair will have an opportunity when he is finished to come up and speak and then he is going to ask the Committee to render a decision on his requests.

**Solicitor,** on behalf of the Administration, called Police Chief Winquist as a witness. Solicitor provided approximately nine exhibits and asked that they be made part of the minutes.

On motion by Councilman Paplauskas, seconded by Councilman Wall, it was voted to accept the submissions by Attorney Verdecchia as part of the minutes. Motion passed unanimously.

**Solicitor** asked Colonel Winquist if in April and May of this year, to his knowledge, the proprietor, Mr. Hamlet Lopez, was the target of an investigation. Colonel Winquist stated, yes. Solicitor asked Colonel Winquist who was conducting that investigation. Colonel Winquist stated the Rhode Island State Police High Intensity Drug Trafficking Area Task Force and the Cranston Police Department was involved in assisting the State Police in any way. Solicitor asked Colonel Winquist, specifically to 349 Dyer Ave. Pregame Lounge, if any investigation has taken place at that particular location by either the State Police or the Cranston Police. Colonel Winquist stated, yes, Detectives from the Heightened Task Force received information that narcotics were being distributed from that location, 349 Dyer Ave., as well as several other locations across the State and the owner of the establishment, Hamlet Lopez, and family members were involved in this large scale narcotics distribution network. Solicitor asked Colonel Winquist to refer to the Exhibit that has been made part of the record by the Committee and asked if that is an application for a search warrant, which was made to Judge William Trezvant of the Rhode Island District Court on or about April 30th of this year. Colonel Winquist stated, yes, that is correct. Solicitor asked Colonel Winquist if the area and location to be searched was the location of 349 Dyer Ave. 1st Floor basement and that is the location of Pregame Lounge. Colonel Winquist stated that that is correct. Solicitor asked, as a result of the

search of those premises, did the State Police retrieve any evidence consistent with the trafficking of narcotics? Colonel Winquist stated, yes, they did. Solicitor asked Colonel Winquist what was seized at 349 Dyer Ave. by the State Police. Colonel Winquist stated a PX380 semi-automatic pistol, notebooks and ledgers, narcotics, currency packaging materials that includes baggie cellophane wrapping, digital scales and assorted paperwork for Hamlet Lopez. Solicitor asked if the notebooks and ledgers are types of items that are kept in narcotics trafficking, in his experience? Colonel Winquist stated that in his experience, yes, they use that to record narcotics transactions, the amount of money that is owed, all things associated with illegal narcotic sales. Solicitor asked if there were other searches conducted by the State Police as part of their investigation of Mr. Lopez besides 349 Dyer Ave. Colonel Winquist stated, yes, there were other locations in other cities and towns. Solicitor asked if the reason for that is because this was a fairly extensive drug operation involving multiple locations, not only at Pregame Lounge. Colonel Winquist stated that that is correct. Solicitor asked if Mr. Lopez was eventually charged with violations of any narcotics laws. Colonel Winquist stated, yes, he was. He was charged with multiple narcotics trafficking offenses and he is currently at the Adult Correctional Institution based on that arrest in those charges. Solicitor stated that it appears that Mr. Lopez has been charged with at least fifteen felony counts ranging from drug trafficking to illegal possession of firearms. He asked Colonel Winquist if that is correct. Colonel Winquist stated that that is correct. Solicitor stated that in addition to this investigation involving drug trafficking, going back to approximately March of last year right up to the present date, he asked if the Cranston Police had occasion to respond to Pregame Lounge for any reason. Colonel Winquist stated that they have responded there on multiple occasions for large disturbances, unruly crowds, people intoxicated, assault of behavior, being open after hours. It has been a frequent call for service at that establishment. Solicitor indicated to Exhibits 4-9 and asked Colonel Winquist if those are incidents reports generated as a result of the responses by the Cranston Police Department, which he just delineated for us. Colonel Winquist stated, yes. Solicitor stated that in addition to the notations documenting disturbances, unruly crowds, assault of behavior, he noticed that many of the calls came in and the responses took place well after the 1 am State Law which requires that the establishments be closed. He asked if that is correct. Colonel Winquist stated, yes. Solicitor asked Colonel Winquist, in his capacity as the Police Chief of the City of Cranston, if he has an opinion as to whether or not the continued operation of the Pregame Lounge poses a significant risk to the health, safety, welfare and morals to the people of Cranston. Colonel Winquist stated that this has been a problem establishment for many years. There was a drive-by shooting in front of this establishment and Officers have been assaulted. It has been nothing but a problem despite our efforts to work with Mr. Lopez and in his opinion, he believes it is a public safety hazard to allow this business to continue to operate in the City of Cranston.

**Solicitor** stated that there is no attorney present, the Committee should allow Ms. Blair to state her peace, but he is not going to allow her to question the Chief. She is not Legal Counsel, but if she would like to make a statement, he will give her that opportunity.

**Chair** asked Ms. Blair if she would like to make a statement. Ms. Blair stated that she would like to have another hearing date scheduled since her attorney was not able to attend due to testing positive for COVID.

**Solicitor** stated that unfortunately, this is not something new. This has been, as the Chief testified, an ongoing problem for the residents and the City of Cranston for at least the past 3-4-5 years. As everyone knows, the City is not in the habit of shutting down businesses, but there are those exceptions, which occurs now and then which pose such a threat and a nuisance to the people of Cranston that we are basically left with no other choice. Just for the Committee's recollection, previously, this Committee did vote to revoke the Entertainment License of Pregame Lounge. At that time, he did not ask for revocation of their BV License or their Food License because he felt and believes the Committee agreed that the majority of the problems we were experiencing there stemmed mostly from the Entertainment License that was being offered particularly on the weekends and particularly Sunday nights so we thought that by eliminating the Entertainment aspect of their business that would bring them into compliance and we would not have any further problems. Unfortunately, and he only learned of this maybe a month or so ago, he was approached by Chief Winquist as well as Major Patalano, who informed him of what had taken place there and this is extraordinarily serious. This may be more serious than the shooting episode that took place back in March of 2022 and Mr. Lopez was the proprietor, the Manager, and there was an appearance before this Committee as well as the Department of Business Regulations. Mr. Lopez is incarcerated at this time and is facing very very serious charges and the thing that has to be emphasized is that this is not just an isolated incident. This seems to be a various serious network of drug trafficking that was taking place and the evidence is incontestable that the Pregame Lounge, while not the sole repository of illegal narcotics and drug paraphernalia, was certainly one of them and that is enough. This was a large scale drug operation. This was not someone selling marijuana cigarettes out of the basement. This was major. We have bent over backwards to try and give them opportunities to come into compliance. What is more disturbing is there were several in the past year alone of responses by the Cranston Police Department for things as the Chief testified to as disturbances, people refusing to disperse, insults directed at the Police, assault of behavior and what is more disturbing is that most of these calls came in well after the State Law requirement that a BV License holder is required to stop business at 1 a.m. Some of these calls were 2, 2:30, 3 a.m. That in of itself is a serious violation. He read one report, which is part of the record, in which Mr. Lopez was asked why there were so many people still in the establishment well after closing time and the Police counted 40 people and his response was they were workers. The Pregame Lounge is probably not even the size of this Chambers and he is telling the Police that all the people in the establishment after closing time were workers, which is frankly insulting.

Solicitor stated that he is asking that this Committee vote to revoke the BV License of Pregame Lounge as well as the Victualling License of Pregame Lounge. Essentially shutting them down. He can only sympathize and feel for the neighbors who have had to put up with this for the past several years and he thinks they have pretty much given up and that should not have happened. Those people have a right to enjoy their property, they are Cranston taxpayers and they are Cranston residents. They should not have to put up with this and we have given them more than ample opportunities. He is asking for a vote and a motion that after hearing the evidence, that this Committee vote to revoke the licenses which he just mentioned. He sympathizes with Ms. Blair. She is in a tough predicament. Mr. Lopez has been front and center these past few years and he knows she is here because he can't be. He did reach out to Attormey

Cooper and he was informed by his Office that he was ill, unfortunately, this is not a matter that can wait. A continuance for another month under these conditions, he thinks is doing a disservice to the people of Cranston and neither Attorneys have entered an appearance so we are not even at that point yet. He did have a conversation with Attorney Hemond and he does not know if he is even going to end up representing this establishment. He is asking that this Committee deny any request for continuance and take a vote this evening.

On motion by Councilman Donegan, seconded by Councilman Campopiano, it was voted to revoke the Liquor License and Victualling License for Pregame Lounge. Under Discussion:

Councilman Donegan stated that it is sad that it has come to this. He has had the honor to represent this neighborhood for the past five or six years on the City Council and he can say pretty definitively that he has received more complaints about this establishment than anything else, more than rats or speeding and it has gotten to the point that people have just kind of given up, as Solicitor stated, because they are so used to it and people should not have to live with that. It is unsafe and it is unfair to the neighborhood. We have given them chances and they have each time spit in our face that this is still going on and they have no business still operating here in the City of Cranston. It is a threat to the public safety, it is a threat to the neighbors and it is threat to all of us.

**Solicitor** asked that two separate votes be taken, one on the Liquor License and one on the Victualling License, so the record is clear.

Motion and second were withdrawn.

On motion by Councilman Donegan, seconded by Councilwoman Haroian, it was voted to revoke the BV Liquor License for Pregame Lounge.

#### Under Discussion:

**Councilwoman Haroian** asked if this means the business cannot operate as of this evening. Solicitor stated, absolutely. Once this vote is complete this evening and licenses are revoked, they cannot operate legally and he is going to speak to Chief Winquist about that.

**Councilman Paplauskas** stated that he is in full support of Councilman Donegan's motion. This Council and this Committee has given this establishment way too many bites at the apple over the years. We have been considerate, passionate, we have listened, we know the Police Department has tried to work with them on numerous occasions and the incidents keep getting worse and worse as time goes by.

Roll call was taken on above motion and motion passed unanimously.

On motion by Councilman Donegan, seconded by Councilman Campopiano, it was voted to revoke the Victualling License for Pregame Lounge. Motion passed unanimously.

**Solicitor** addressed Ms. Blair and stated that for the record, he needs to tell her that as of tonight, she cannot operate. If she operates illegally without these licenses, that in and of itself would constitute another ground to revoke a license if and when she should ever get those licenses restored. Also, he pointed out that the Chief of Police, under our Ordinances, if he feels it constitutes n emergency situation, he can literally close the business down. He states this because it needs to be clear for the record that those are the possible ramifications if the business is not shut down.
