(The following is not a verbatim transcript of comments or discussion that occurred during the meeting, but rather a summarization intended for general informational purposes. All motions and votes are the official records).

SAFETY SERVICES & LICENSES COMMITTEE

Regular meeting of the Safety Services and Licenses Committee was held on Thursday, August 15, 2024 in the Council Chambers, City Hall, 869 Park Ave., Cranston, Rhode Island.

I. CALL TO ORDER BY THE CHAIR:

The meeting was called to order at 9:30 P.M. by the Chair.

III. APPROVAL OF MINUTES

A. Approval of the minutes of the July 1, 2024 Regular meeting.

On motion by Councilman Paplauskas, seconded by Councilman Wall, it was voted to approve the minutes of the July 1, 2024 regular meetings and they stand approved as recorded. Motion passed unanimously.

IV. PUBLIC COMMENT

Robert Murray, Esq., 21 Garden City Dr., appeared to represent transferor for the transfer application for Campanella's.

Patricia Cotoia, 15 Hayward St., appeared to oppose to the liquor license application for Spectacle Management, Inc., d/b/a Spectacle Live Park Theatre. She stated that the prior business caused noise and nuisance which diminished the peaceful enjoyment of her home. Sale of alcohol until 1 a.m. is unreasonable. Although she wants the Park Theatre to be saved, it should not be done so at the peril of the neighbors. These problems also affect their property value.

Pat Krajewski, 376 Pontiac Ave., appeared to oppose to the liquor license application for Spectacle Management, Inc., d/b/a Spectacle Live Park Theatre. She stated that there have been problems in the past with parking, trash and lack of law enforcement. Pontiac Ave. is blocked, cars are parked into the intersection. After events are over, Pontiac Ave. and Auburn St. are totally trashed with food containers, dirty needles, which she has had to pick up. Loud noise after shows going beyond 11-12 at night. This license should not be granted because the Park Theatre has not been a good neighbor.

Brian LaPlante, Esq., appeared to represent the applicant and stated that it is important that everyone recognizes that this is a different operator. Spectacle operates theatres throughout Rhode Island, Massachusetts and New Hampshire and they have a team of people not only at their offices but the theatre itself and because of that professionalism, that ability to bring to bare those resources, he is confident that you are going to have a very good operation and this will truly be a reinvigoration of that important theatre to this area and to this City. They have several scheduled events for the Fall and Winter. This will be an operation that appeals to broad population. The notion that this is going to be a bar or nightclub, is just not the case. Spectacle has put in nearly \$200,000 and they have budgeted \$250,000 in advertising just for this theatre to bring in patrons to their shows. Employment is another key element to this operation and they are hiring right now at all levels of operation.

Chair indicated that the agenda states there is a balance owed on City tangible taxes from the Historic Park Theatre and an email was received today that they owe approximately \$12,000. Attorney LaPlante stated that that is from the prior operator and prior operator communicated with the Tax Collector and resolved the issue today and the Clerk's Office will receive notice that that has been resolved. Chair asked Clerk if something changed from 3 p.m. today when he spoke to the Clerk. Clerk stated that the Clerk's Office has not received anything as of 4:30 today. The Tax Collector indicated to her today that the prior owner did contact him today and was going to be in touch with him tomorrow to make some kind of an agreement.

Council President Marino stated that she heard from the Clerk at the end of the day today and there was no actual agreement that was reached today. There was a contingency of tomorrow, but as of end of day today, no payment had been made of the overdue taxes. In any

event, it needs to be addressed. She asked that the license application be approved subject to that being resolved.

Chair asked Solicitor to advise. Solicitor asked if this entity is separate and apart from Historic Park Theatre. Attorney LaPlante stated 100%. He also stated that Spectacle owes \$-0-to the City of Cranston and should not be adversely affected by this tax that is due for tangible taxes. He communicated with the owners today of the prior operating entity that they will address that obligation in connection with the issuance of this license just like they did address all of the Real Estate taxes that are current with the City to the tune of \$100,000.

Solicitor stated that in consulting with Attorney Angell, the concern from a legal standpoint is that we are not sure whether or not there is some overlap in membership between Historic Park and Spectacle. Attorney LaPlante stated that this applicant, this entity before you, is entirely disconnected from and has no overlapping ownership interest, management interest or other connection, members whether they may be owners, shareholders members or management employee.

Chair asked Solicitor if this could be continued to August 26th prior to the Council meeting since this would have to go before the full City Council anyway as long as the overdue tax issue is resolved before then. Solicitor stated that he does not see a problem with that.

Councilwoman Haroian asked if crowd is expected to be in the theatre at 11-12. Peter Lally, President of Spectacle Live Management, appeared to speak and stated that most of their shows typically start between 7 and 8 p.m. and typically run two hours or so. Midnight is on the far end of some shows. They are not running a bar and they are not running a nightclub. They do run some shows in the afternoon on Sundays and hours would vary from 3 p.m. to 8 p.m. start.

Chair stated that in the past there were events held at the Cinema during the day and it created a catastrophe with the parking. If any event is held during the day, there will not be any available parking since the lot is used by the school children, City employees and Fire staff. He asked what the plans are to use the parking lot and if there is an insurance policy in place, an agreement with the City that has been redone because it is a whole new entity now so there should be a whole new agreement. Attorney LaPlante stated that he believes the operating parking agreement extends to the user. The parking agreement is clear that during the day and during the weekdays, that parking lot cannot be used. Chair stated that has been a problem in the past when the Council received phone calls from people who could not park during the week. Attorney LaPlante stated that he can work with the Solicitor to clarify and comfort everyone about that parking arrangement.

Councilwoman Renzulli indicated to applicant that the Park Theatre has always had to submit a monthly schedule of events for the Committee to review for informational purposes and asked that they work with the Clerk regarding that.

On motion by Councilman Campopiano, seconded by Councilwoman Haroian, it was voted to *continue this license application* to the August 26th special meeting. Motion passed unanimously.

Paul Siu Lun Yu appeared to speak.

Chair indicated that balance is owed on City Tangible tax from former restaurant, Mario's Restaurant is still owed. He asked legal to address the taxes owed from prior owner. Solicitor stated that this is the same issue as Spectacle. The question becomes are these the same entities for legal purposes? It depends on if we have the similar or the same members, is this truly a new LLC? He does not know because he does not have that information. Mr. Siu Lun Yu stated that it is under him and his wife's name and the face in the restaurant is his son. Solicitor asked who the former owner was of Mario's Restaurant. Mr. Siu Lun Yu stated that he does not know, he thinks it was an Italian guy. Solicitor asked Mr. Siu Lun Yu if he or any members of his family have any ownership interest in Mario's Restaurant. Mr. Siu Lun Yu stated, no. Solicitor stated that a new entity is not going to be responsible for a prior entity's obligations whether they be tangible taxes or anything else. The difficulty is ascertaining if they are truly separate and distinct entities. If applicant would like to state under Oath, he could be sworn in.

Councilwoman Renzulli questioned why that can't be done with Spectacle Live. We can't change things around for one and not the other. Solicitor stated that nothing is being changed. They are going to have to produce evidence that they are not. We are going to require that they provide either sworn testimony or affidavit to the effect that these are separate entities. Councilwoman Renzulli stated that we did not offer that to Spectacle Live. Solicitor stated that if this applicant is not represented by legal counsel since he does not see one present. The only information we are getting is from him. If the Committee would like to continue this, that is fine.

On motion by Councilman Campopiano, seconded by Council Vice-President Vargas, it was voted to continue this license application to August 26th Special meeting, if one is held. <u>Under Discussion:</u>

Chair stated that this applicant is not sure if these taxes are owed or not. He has nothing to do with the previous owner. He is not renting from the previous owner.

Council President Marino stated that she had discussion with Attorney Angell and Solicitor Verdecchia that a very simple solution is we cannot, as a body, be responsible for anyone to stand up and just represent that they are different or the same owner of a prior business. There is a very simple solution to that, as Solicitor Verdecchia indicated. They either provide sworn testimony under Oath or even simpler, an Affidavit stating exactly that, that they are in fact different owners and that will solve the problem.

Councilman Paplauskas suggested that the Stenographer swear in applicant and he can state that he is not the owner if that is the truth and then take a motion to reconsider on Spectacle Live and do the same thing because they have actually stated that they have nothing to do with the prior owner so it is the same issue and then we do not have to have them wait and come back from wherever they came down from today and sit through three to four hours-worth of meetings.

Director Moretti stated that in the best interest of the City and the ownership of both entities, they should know what is expected on the 26th because he heard a statement being made specifically about Spectacle Live that their taxes have to be paid. Is that the condition or is it the ownership condition because this particular gentleman, Mr. Siu Lun Yu, is probably going to have a hard job contacting Mario, former owner, to pay his bills. He just wants to be fair to perspective businesses in the City as to what expectations the City Council has in their defense. Chair stated that he is not in a position to make that decision. He needs to be advised by the attorneys in the room to how to proceed with this. He asked if we could have our Economic Development Director contact this gentleman between now and the 26th and get him to the point where he needs to be. Director Moretti stated that Administration needs to hear from the Council what is required. He is not going to make the Economic Development Director the lawyer for the City of Cranston. Solicitor stated that to protect the legal interest of the City, we simply cannot accept just unsubstantiated representations. We need a little more assurance from a legal perspective. If someone wants to submit an affidavit or if someone wants to raise their right hand and swear under Oath that the two business entities are truly separate and apart and that this is a new business entity, that is fine, but at least that protects the City's legal interests. That is all we are interested in.

Chair recommended applicant be sworn in. Stenographer swore in applicant.

Solicitor asked Mr. Siu Lun Yu, the business entity that was known as Mario's Ristorante, did either himself or any family members or associates have any legal interest in ownership of Mario's Ristorante? Mr. Siu Lun Yu stated, no. Solicitor asked if this LLC, Vincent Restaurant, is a complete separate business entity from Mario's Ristorante? Mr. Siu Lun Yu stated, yes.

On motion by Councilman Campopiano, seconded by Councilman Wall, it was voted to recommend approval of this license.

Under Discussion:

Councilman Campopiano asked if it would matter if he is using the same equipment that was there previously. Solicitor stated, no, because he does not know how much time has

gone by since that equipment has been used. Mr. Siu Lun Yu stated that it is all new equipment which he purchased.

Roll call was taken on motion to recommend approval of this license and motion passed unanimously.

On motion by Councilman Campopiano, seconded by Councilman Wall, it was voted to reconsider vote for Spectacle Live liquor license application. Motion passed unanimously.

Stenographer swore in Attorney LaPlante and Mr. Lally.

Attorney LaPlante asked Mr. Lally what his interest is, if any, in Spectacle Management, Inc. d/b/a Spectacle Live. Mr. Lally stated that he is 100% owner of that business, which he started in 2013. Attorney LaPlante asked Mr. Lally if he has any ownership interest whatsoever in Historic Park Theatre LLC, the former operator of this property. Mr. Laly stated that he does not have any interest. Attorney LaPlante asked Mr. Lally if there is any management overlap whatsoever between his company, Spectacle Management, Inc. and former operator Historic Park Theatre LLC. Mr. Lally stated, none at all. Attorney LaPlante asked Mr. Lally if Spectacle has any ownership interest whatsoever in Historic Park Theatre LLC. Mr. Lally stated, no.

Solicitor stated that all the questions were in reference to Historic Park Theatre LLC, what about Historic Park Theatre Realty LLC, which is a separate LLC? Attorney LaPlante stated that to be clear, the prior operator, he thinks that was assessed the tangible taxes, was Historic Park Theatre LLC. He asked if that is correct. Solicitor stated that this is a separate question, this was a separate entity. We need to know if there was any connection or any overlap with Spectacle and Historic Park Theatre Realty LLC. Attorney LaPlante asked Mr. Lally if he has ever had any ownership interest whatsoever in any entity that has owned the Park Theatre at which he is now operating. Mr. Lally stated that he has not. Attorney LaPlante asked Mr. Lally if any owner of the real estate, at which he is operating, has ever had any interest in Spectacle. Mr. Lally stated that they have not. Attorney LaPlante asked Mr. Lally if he has any interest whatsoever in any of the entities that have been mentioned this evening. Mr. Lally stated that he does not.

On motion by Councilman Wall, seconded by Councilman Campopiano, it was voted to recommend approval of this license application. Motion passed unanimously.

Khamla Nirandone appeared to speak.

Chair indicated that according to the Clerk's Office, Certificate of Occupancy has still not been issued and there evidently is some communication problem between Zoning, the Clerk's Office and the applicant where they call it a zoning disconnect and she is not sure what she needs to do to get the Certificate of Occupancy. He asked Ms. Nirandone to explain. Ms. Nirandone stated that the prior business was already a coffee shop. When she was ready to apply, she checked with the Department of Health to see that the business was already established under that category and they recognized it as it being a coffee shop and was all set. The problem is, according to Inspections, she needs to do all the plumbing over again, which costs a lot of money. When she first started that process and went to the Clerk's Office, they told her that they recognized that business as being s smoothie coffee shop so she thought everything was fine so she started changing the countertop to make it wider and started investing in other things and then she found out that she can't get a Certificate of Occupancy. She told the Clerk that she went to fill this form from the Zoning Board and they said they do not have record of that and they said it is already all set so she went through the whole application process and come to find out she needs a Certificate of Occupancy. She has already spent a lot of money so this is kind of a curveball. She does not know what she is asking for at this point and how she moves forward.

Solicitor stated that the Clerk gave him the Zoning Certificate that simply indicates that it is an allowable use n a C-2 Zone, but the approval is subject to all approvals, permits, inspections and new Certificate of Occupancy prior to establishing occupancy. He has no idea what she actually needs to obtain the Certificate of Occupancy, but the bottom line is she does not have it whatever the reason is. From a legal perspective, she cannot open without a Certificate of Occupancy. Ms. Nirandone questioned why the previous business was allowed to operate before and now that it is a new business,, a Certificate of Occupancy is required. How did that business have a license to run a smoothie shop? Solicitor stated that that answer would have to come from Building Inspections.

Chair asked if the Clerk's Office can contact Mr. Pikul, in the Building Inspections Department, tomorrow and try to resolve this. Clerk stated that the Clerk's Office did attempt to contact that department multiple times today, but was no able to speak to anyone to get clarification, but will try again tomorrow.

Ms. Nirandone stated that the Inspections Department told her that the previous business never had a Certificate of Occupancy. Chair asked Clerk if this is true. Clerk stated that she does not have that information this evening.

Solicitor stated that the prior business could have been operating illegally for all we know.

Chair asked Ms. Nirandone to contact the Clerk's Office in the morning.

Council President Marino suggested continuing this license application to the 26th if a special meeting is held and in the meantime we will try to get answers from the Inspections Department as to whether or not there was a Certificate of Occupancy from the prior business because until that happens, the applicant does not have her Certificate of Occupancy and we can't do anything more than that at this time.
