**Council Vice-President Favicchio** asked if Mr. Hunt was notified of this meeting. City Clerk stated, yes.

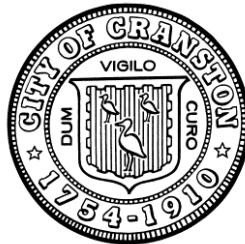
