### VIII. SHOW CAUSE:

Bouni's, LLC. d/b/a X-Hale Hookah Lounge(Cont'd from 1/6/2020)

Playing loud music without a Public Entertainment license

Hours: W, Th, Fr, Sat, Sun open until 11pm

The following discussion took place on the Show Cause Hearing for the loud music issue:

**Nicholas Hemond, Esq.**, appeared to represent the applicant and stated that from the last meeting, the sound engineer his client had at the last meeting, went to the business and measured the assessment. Subsequent to that, the parties could not come to an agreement with a price and so the applicant went to an acoustical supplies store and purchased some sound proofing materials. Attorney Hemond stated that he has reviewed the information from the Police Department and since the last meeting, there seemed to be calls from the 19<sup>th</sup>, 23<sup>rd</sup>, 24<sup>th</sup> and 30<sup>th</sup> of January of constituents regarding noise. He also indicated that the sound proofing was installed this past Friday. This business is in a zoned approved area and there is no evidence that he has been provided with that indicates his client has violated the noise level or decibel readings. He does not believe denying this license would be merited and would stick when reviewed by a Court. This Committee could place restrictions if it so chooses.

### Mouayd Alaaboun appeared to speak.

**Chair** stated that since the last meeting, the Committee imposed an 11 p.m. time for music to stop. He asked applicant if he has gone beyond the 11 p.m. Mr. Alaaboun stated that during the weekdays, no. Weekends, the music goes to approximately 12:30 a.m.

**Solicitor** stated that at the January 6<sup>th</sup> meeting, the minutes indicate that one condition was that the business close at 11 p.m. every day. Attorney Hemond stated that the minutes state that the business had to turn the music down at 11 p.m. Solicitor stated that that is not what the minutes state. He referred to the Ordinance for Entertainment License and also addressed the issue of having a DJ not being allowed. Attorney Hemond stated that having an DJ playing from a playlist is allowed and allowed by Statute.

**Solicitor** called on Major Quirk to testify regarding the incidents of complaints that have taken place at this establishment since the last meeting. He asked Major Quirk when the first time was that this came to the Police Department's attention. Major Quirk stated that sometime in November, the Police Department received complaints of serious noise and the Police went to the property. He gave a summary of contacts going there. Solicitor provided the Committee a handout of reports of complaints made to the Police Department. Solicitor asked Major Quirk if these documents are true and accurate documents from the Police Department. Major Quirk stated, yes. He also stated that these are reports of Officers who responded to the business and also included are documents from dispatch logs.

**Solicitor** indicated to the dispatch log and questioned what the January 24<sup>th</sup> call was for. Major Quirk stated that according to the dispatch log, the caller from 111 Rhode Island St. reporter loud music coming from this business. Solicitor indicated to the January 30<sup>th</sup> call on the dispatch log and questioned what this call was for. Major Quirk stated that at 12:45 a.m. caller stated that base was too loud coming from this business. Solicitor indicated to the dispatch log and questioned what the January 23<sup>rd</sup> call was for and when this call came in. Major Quirk sated that call came in at 11:29 p.m. from 111 Massachusetts St. of complaint of loud music and thumping coming from this business. Solicitor indicated to the dispatch log and stated that a second call came in on January 30<sup>th</sup> at 11:20 p.m. and questioned what this call was for. Major Quirk stated that complaint was regarding base noise and loud music.

Attorney Hemond asked Major Quirk if Officer who responded to the business on January 19<sup>th</sup> issued violation for noise or if he did a decibel reading that evening. Major Quirk stated that he does not believe so. Attorney Hemond stated that the narrative states that 'music isn't loud according to Officer who responded'. Attorney Hemond asked Major Quirk if Officer who responded to the business on January 23<sup>rd</sup> issue any violations. Major Quirk stated that he does not believe so. Attorney Hemond asked Major Quirk if there is any evidence at all that the sound was not within the Ordinance. Major Quirk stated that he cannot be sure. Attorney Hemond asked Major Quirk if any violations were issued on January 24<sup>th</sup> or the three times on the 30<sup>th</sup> that the Police responded. Major Quirk stated that he does not believe so.

**Councilmember Stycos** asked what the fine is for operating without an Entertainment License. Solicitor stated that the fine is up to \$500 for each violation.

**Councilmember Hopkins** asked if there were any liquor violations issued recently. Major Ouirk stated that there were none noted according to the reports.

**Councilmember McAuley** stated that at the previous meetings, applicant stated that he would be willing to install double doors with a vestibule. He asked if he was able to do that. Mr. Alaaboun stated that he contacted his landlord and he would not allow it.

**Councilmember Brady** stated that he would recommend a fine and have the Police check on this business periodically.

On motion by Councilmember Brady, seconded by Council Vice-President Favicchio, it was voted to impose a \$500 fine and additional regulations if warranted and fine to be paid within one week. Under Discussion:

**Councilmember Donegan** asked how we would distinguish the definition of a DJ. Solicitor referred to Section 54.64.061 of the Code. Attorney Hemond stated that a DJ is an act. Playing from a preset list is not a DJ.

**Councilmember Donegan** stated that the fine is too much and the business has made efforts to address the problem.

**Councilmember Brady** stated that there are neighbors present this evening. He feels our Ordinances needs to be redrafted to be clear on the guidelines for the businesses. In his opinion, this business has been violating the Ordinance.

**Council President Farina** stated that our Code is very clear regarding a DJ and based on our Code, this business has violated the Ordinance. He supports the \$500 fine. He also stated that our Code may not be correct, but we have to follow what is on the books. He asked that the Solicitor look into the current Ordinance to see if it needs to be amended.

**Councilmember Hopkins** stated that every restaurant in the City plays some kind of music and no one is calling to complain. With this business, all the residents are asking is that this business turn the music down.

Roll call was taken on motion to fine this business \$500 and motion passed unanimously.

The following discussion took place on the Show Cause Hearing for Public Entertainment license issue:

**Nicholas Hemond, Esq.**, appeared to represent the applicant and stated that his client will try to continue to make progress and get the music under control and show the City Council that they can do better.

**John Savian**, Warren resident, appeared to speak and stated that he manages property on Rhode Island St. that his girlfriend owns. He stated that he has no interest in fining this business or shutting this business down. At the last meeting, the business owner was told to keep the music at ambient level sound, but he is tired of getting phone calls from tenants regarding the loud music. The front of the building is not the problem. The homes are all in the back of the building. The speakers are not in the front of the building. The problem is coming from the back of the building. This is complete lack of respect from the business to the neighborhood. This business owner has not followed any instructions that he received last time he was before this Committee.

**Thomas Strumenski**, 105 Mathewson St., appeared to speak and stated that the music sound has been taken care of at his property. His concern is the extreme noise at closing time. This past weekend, it was extremely noisy and there was screaming and shouts at 1:30-1:45 a.m. outside. This is very disturbing and needs to be addressed.

**Lawrence Celani**, 121 Massachusetts St., appeared to speak and questioned if the business owner had a sound proofing company do the work or if he did it himself because he texted the business owner last week and indicated that he is tired of complaining. He also indicated to the business owner that it seemed to him that the loud music had gotten worse. He is vehemently opposed to an Entertainment License to this business because the music issue has not been resolved and also the issue of the DJ.

**Paul Celani**, 111 Massachusetts St., appeared to speak and stated that the loud music is still going on. Attorney Hemond stated that his client worked with Davis Construction to install the sound proofing. They were paid \$2,200 to install the equipment and they finished the work this past weekend.

**Councilmember Brady** suggested continuing this item for review in two to three months for decibel readings.

**Councilmember Vargas** asked if the applicant would be willing to turn the base level down or play the music at ambient level. Mr. Alaaboun stated that he is constantly lowering the music. He thinks it is a communication thing with the neighbors because he is not in their homes to hear the sound. He would need the neighbors' phone number to contact with while he does decibel testing to see if any changes he makes are making any difference.

**Councilmember Stycos** stated that he could not vote for an Entertainment License this evening based on the fact that we do not know what has been done there and how effective it is and the neighbors have not been spoken to to see how effective it is.

**Councilmember McAuley** stated that he would be happy to work with the applicant because he thinks he can help him while he goes through these transitions.

**Councilmember Hopkins** questioned if the City has standards for insulating to stop the noise. Chief MacIntosh asked if permits have been filed and if plans have been approved. Mr. Alaaboun stated, no, he has a drop ceiling and replaced with acoustic tiles.

**Attorney Hemond** stated that his client can show the Fire Chief the package the tiles came in to see if they are City approved and safe.

Council President Farina stated that, based on our Ordinance, this business cannot have any kind of DJ.
