## CITY OF CRANSTON BOARD OF CANVASSERS Election Meeting of April 2, 2024 – <u>OFFICIAL MINUTES</u>

The Cranston Board of Canvassers met on April 2, 2024, in a meeting advertised in accordance with the Rhode Island Open Meetings Act on March 11, 2024. The meeting was called to order by the Chairperson, Kirk McDonough, at 6:01 a.m. It was held in the Canvassing Authority Office, Room 100, at Cranston City Hall.

Mr. McDonough called the meeting to order. New Board Member Steven Piscopiello and Board Alternate Peter Rivelli were sworn in by the Registrar prior to the start of the meeting. Mr. McDonough welcomed the new members to the Board of Canvassers.

PASSED ROLL CALL VOTE – 3-0 – Ms. Moronta, Mr. Piscopiello, and Mr. McDonough voting aye.

All 12 polling locations were opened on time throughout the city. Turnout was exceptionally light, and no notable incidents were reported. Board members and staff visited the polling locations and assisted poll workers throughout the day. The police detail provided security. A voting machine had jamming issues at Scottish Rite, however a second machine was functioning well and state BOE technicians responded promptly.

There were no actions of the Board taken that required a discussion or vote at City Hall.
