He questioned if these businesses are operating without a license and having not paid tangible taxes. Solicitor stated that he has no personal knowledge whether they are or they are not in operation. He notes that with Rainbow Water, the agenda states that they have not been served. He is not sure why it is taking all these months to serve the Cease and Desist if in fact that is accurate information. That is the first question as to whether or not they are operating.

Chair asked what the procedure is would be. It is not Safety Services Chair or Councilmen's responsibility to go to these businesses and say to them that they are operating without a license. Solicitor stated that approximately a year and a half ago, in an effort to streamline this process, he had given a legal opinion that it was not necessary for the mobile food establishments to actually appear before the Committee. He is not sure why they are on the docket this evening and why these people have had to wait two hours for something that really should have been done

administratively, which going forward he reemphasized his earlier legal opinion that he does not believe it is necessary for these people to be inconvenienced and have to come before the Committee unless there is an issue such as #5 on the agenda, which indicates that they need a mobile license from the State. That is a reason to come before the Committee. The Committee can query that and find out what is going on, but the rest, there was really no need to have them be here.
