Cranston 2024 Comprehensive Plan**

There will be a Public Hearing on proposed **Ordinance No. 09-24-01** to consider the adoption of the proposed **Cranston 2024 Comprehensive Plan**.

The 2024 Comprehensive Plan (Phase 1 of 2) is a complete and substantial update to the existing 2012 Comprehensive Plan. The 2024 Comprehensive Plan includes two new chapter elements as required by State law: Energy and Natural Hazard Mitigation. The Goals and Policies and Action Items from the 2012 Plan are largely carried over intact unless they were considered defunct or no longer consistent with State Law.

The public hearing will be held in the Cranston City Hall Council Chambers, 869 Park Ave., Cranston, RI on **Thursday, September 26, 2024 at 5:30 p.m.** before the **Ordinance Committee**.
